- Tools that are even more innovative, fun and effective, bringing us closer to people's real experiences. For instance, <u>Dying Without a Will:</u> <u>Who Inherits?</u> Take a look at this publication and you'll be convinced!
- Pursuing our **internal training "academy,"** in particular with the legal communication course developed for McGill University, so that the team can continue to better deliver our knowledge of the law and legal education to the public in clear language. Enhancing the legal competencies of the people who deal directly with the population is our driving force!
- Sponsored by the Minister of Justice of Quebec, the **4**th edition of the Quebec Legal Education

Week beat all records: 6,000 youths took part. This record-breaking participation was thanks to a hundred volunteer legal professionals from across Quebec. THANK YOU for bringing the law into the classroom!

- A TV campaign, Question droit ? Éducaloi !, broadcast on TVA, that reached 420,000 people. Bonus: a lawyer from the daily Indéfendable recommended Éducaloi's website to help a citizen unravel her legal situation!
- Not to mention the 8.6 million visits to our website that offers 1,600 legal information tools, always available for free, in French and English.

All of this was driven by a spirit of motivation that unites our Board members and our steadfast team: the motivation to continue making the law more and more accessible to the Quebec population. We are forever grateful to **YOU** for your incredible dedication.

Impact steering the way

Growing, innovating, serving... Yes, but in what direction? The direction mapped out by our "**impact pathway**" developed by a passionate team mobilized around this major unifying project. It challenges us, forces us to question ourselves, to think about the **social impact** we want and can have. It brings us back to what's essential: fruitful collaborations, the public we want to reach first and foremost (the people on the frontlines!), our key areas of expertise in clear communication and legal education, without which our very existence would be meaningless.

Perhaps you noticed that the cover of this year's annual report refers to our impact-based approach. That's because now, more than ever, we're choosing projects based on the pre-established impact we want to have. We're moving towards an organizational culture of learning; towards complementary partnerships with social and legal actors rather than repeating actions and working in silos; and, especially, towards our commitment to developing clear communication skills among both our partners and our staff working on the ground.

Next year Éducaloi will be a quarter of a century old! It will be a year to recognize the achievements and tireless work of the teams and boards of directors who have paved the way forward for us. It will also be a time to look far ahead, as we renew our strategic plan.

This is the first time Éducaloi has ever had its own radio show to talk about everyday legal issues! The show, called *Angle droit*, was created to expand our reach in Quebec and to try a new approach to **raising the public's interest in law**. This was not only a way for us to test a new method of communication, but also an opportunity to promote the organization and its team.

Several **personalities** came into the studio to talk about immigration, youth protection, medical assistance in dying and fraud prevention, like Nadja Pollaert, Executive Director of Doctors of the World; Judge Lise Gagnon of the Court of Quebec; M^e Véronique Hivon, former member of parliament for the Parti québécois; and former investigator with Sûreté du Québec, Paul Laurier.

Let's talk legal life skills in the podcast Ça dépend François

This new podcast features five episodes in which Éducaloi's legal professionals play their part as they talk about the law in a different way. Each day, François comes up against legal dilemmas that leave him scratching his head. With the help of Éducaloi's plain language specialists, he learns that the answer is not always yes or no, but often... "It depends!" Already, **1,120 listeners** have been immersed in François' misadventures and gained insights into the world of law, on CIBL. A total of **1,265 episodes** have been downloaded on the various listening platforms.

Innovative content and tools

New needs emerge and with them, new content, pilot projects and new tools.

NEW CONTENT ADAPTED TO EACH PERSON'S REALITY

Pilot project in Nunavik: Co-designing an educational kit for Inuit youth

This pilot project grew out of discussions and meetings with Justice Pro Bono and members of the administration and teachers at the Ulluriaq school in Kangiqsualujjuaq, Nunavik. The objective? To co-design an educational kit (adapted from the in-class workshop Pick your side!) that takes into account the **realities and culture of Inuit youth** with goals of:

- developing the legal competencies of youth and teachers to increase the **agency** of people in Nunavik and help improve their access to justice;
- informing Inuit youth and giving them tools in terms of their legal **rights** and **obligations**;
- engaging Inuit youth in reflecting on the current justice system and what it could become.



Bill 101 (*Bill 96*): create a workshop for organizations that support English-language communities

After consulting with **20 English-language non-profit organizations** (NPOs), we identified a lack of clear and up-to-date legal information on the amendments to Bill 101 (after the adoption of Bill 96). Éducaloi created and ran a workshop entitled "Bill 96 and Non-Profit Organizations: What You Need to Know" for these NPOs to inform them of their **obligations** and the **impact of this bill** on their daily activities.

Immigrant women: Co-creation to improve intervention

The project responds to a pronounced lack of accessible legal information for immigrant women who are thinking of separating. The ultimate goals are for them to **recognize** and **assert their rights**.

Éducaloi worked hand in hand with frontline workers at La Maison bleue and Femmes du Monde to understand the challenges these women face and to ensure the **project's sustainability**.

TECHNOLOGICAL TOOLS FOR A DEEPER UNDERSTANDING

Without a Will: Who Inherits?: Concrete answers through an interactive tool

Over 50% of Canadians still don't have a will despite its many advantages.

Éducaloi wanted to create an interactive tool available on its website so that Internet users can find out who would inherit their assets if they were to die without a will. The objective is to **raise awareness and effectively inform** the population of Quebec about the **consequences of not making a will**.

So far, over **58,000 people in Quebec** have passed the test, making this page one of the most visited on our website!

Cyberlearning: Adapting to new content practices to improve learning among Internet users

Given the popularity of our workshops, Éducaloi found a way to make them accessible at all times and to as many people as possible, online. To make the pathway for Internet users as easy, educational and fluid as possible, we put in place a cyberlearning tool that offers interactive content and sequenced videos on targeted themes. The first workshops on caregiving in French and English will be available by the summer on <u>educaloi.qc.ca</u>.

Development through learning and for learning.

Towards a culture of learning and beyond

Developing new competencies, innovating, being informed, cultivating an interest in law, understanding it and feeling confident. The Éducaloi team never stops learning, training and growing to better support the changing legal and educational worlds, so that it can better respond to the current and future needs of the population of Quebec in terms of legal information and education.

LEARNING INTERNALLY TO MOBILIZE EXTERNALLY

The Forum québécois sur l'accès à la justice civile et familiale (Quebec forum on access to justice in civil and family law matters): training in leading and facilitating groups.

Éducaloi was mobilized to facilitate the second day of reflection on access to justice in civil and family law matters, bringing together **over 150 people** to:

- evaluate the progress made in Quebec since the publication of the **Cromwell report** on access to justice (2013);
- highlight initiatives designed to improve overall access to justice;
- explore **new avenues for reflection** for the next 10 years.

The team's enthusiasm to learn and receive training in facilitating a forum made this a rallying and hands-on event, and a wholehearted success for everyone who participated!



Public Legal Education Association of Canada (PLEAC): Co-creation to improve education

This workshop explored the best **co-creation practices in legal education**. Marginalized communities among the general population can be more difficult to reach and can have different needs. Éducaloi shared the lessons learned from its experience in co-creating legal education workshops with a variety of external partners in order to better serve this public. Yet another way to **collaborate** and **discuss our external discoveries and observations**!

RAISING AWARENESS AMONG INTERMEDIARIES FOR WIDER DISSEMINATION

Sexual violence: Training to provide better support

Éducaloi ran **17 new training sessions** for people working in higher education to **raise their awareness** and **give them the tools** they need regarding **criminal offences** of a sexual nature and the criminal legal process.

This project began in 2018 and, this year, it reached the critical mass of people in the network (**241 people**) who are now properly equipped to respond to certain legal issues on this theme.

Quebec Culture and Citizenship (QCC): Training Quebec teachers

A total of **293 teachers** were trained in the legal concepts addressed in the QCC program that will be offered in September 2024, to replace the Ethics and Religious Culture (ERC) program. Created by Éducaloi, this training is designed to help teachers feel confident about teaching essential legal concepts to students, and have a **direct impact on their education**.

This training is the fruit of several months of discussion and reflection with the Ministère de l'Éducation du Québec. Éducaloi also took part as an expert in legal education to develop several **educational tools that will help in implementing the QCC program**.

McGill University: Teaching clear legal communication

Éducaloi developed a two-credit course as part of **McGill University's graduate program in legal translation**. As a result, 16 students were trained in the approach to clear legal communication as well as its good practices.

Developing this course was an opportunity for Éducaloi to set out a solid learning pathway for the teaching of these concepts. This pathway was employed again for internal training and offers **great potential in terms of its use in academic settings.** Creating a course in CLC to be taught in university law programs is in fact one of the 25 initiatives that we hope to implement in the medium term.

Development with multiple impacts

Looking ahead to boost our impacts

Éducaloi simultaneously led several high-impact projects for the organization itself, for the legal professionals it supports through consulting and, especially, for the general population that Éducaloi serves every day.

INCREASING AND IMPROVING OUR SCOPE

A clear direction to enhance our impact

In 2023, Éducaloi embarked on an **"Impact and strategic clarity"** coaching stream with Innoweave.* Through this stream, Éducaloi achieved three main results:

- Stating Éducaloi's targeted impact
- Developing our "impact pathway" (also called "theory of change")
- Working on a plan to put our impact pathway in action

We can (re)affirm that our expertise – in legal plain language and legal education – is key to our approach, because it's what makes our **content and actions unique**. This approach also allowed us to identify another target public: everyday front line workers. To avoid the duplication and overlapping of our actions, we want to work with our collaborative partners' missions in a more **cohesive** and **complementary** way.

The impact pathway helps us better situate **our strengths and our unique position** in Quebec's social

fabric so that we can concentrate on the desired impact of our actions and **enhance the population's access to justice**. This will serve as the foundation of our 2025-2029 strategic planning exercise.



Developing an awareness campaign on caregiving for the general public

With the aging of the population, more and more people are finding themselves in caregiving situations. And yet, the **rights and responsibilities** of caregivers and those being cared for are largely **unknown, although legally set out**. For the third year in a row, Éducaloi led a variety of **awareness activities** including a vast communication campaign to inform the Quebec population of the **tools**, **recourse and actions** at their disposal.

The results speak for themselves! (See the box on the right.) This awareness campaign was made possible thanks to the financial contribution of the Ministère de la Santé et des Services sociaux.

Optimizing for greater impact

At the moment, Éducaloi is prioritizing the creation of **"ready-to-use" legal information workshops for adults**! These workshops are designed to be facilitated by volunteer legal professionals in community organizations working with people who want to learn about their rights and responsibilities. This new workshop format for adults is part of our ongoing commitment to **teach and transfer our competencies in clear legal communication** to people on the frontlines who respond to the Quebec population in need of simple and accessible legal information. The project that began in 2023 will be online in January 2025! Stay tuned!

SHARING OUR EXPERTISE TO MAXIMIZE THE QUEBEC POPULATION'S ACCESS TO JUSTICE

Tribunal Administratif du Québec (TAQ) : Explaining legal terms in plain language to better respond to the needs of the population

The TAQ called on Éducaloi's help to:

- identify terms and expressions used during court procedures that are difficult to understand;
- **create a glossary** that simplifies or explains certain terms and expressions.

The vocabulary used by the TAQ has a **direct impact on how effective its communication with the public is**. It can help the public understand the TAQ's procedures so that people feel satisfied with their legal process before this tribunal. This consulting project should have a **significant impact on the public's access to administrative justice in Québec**. The TAQ was a partner that knew how to adopt the right means to support a long-term change process.

The Ministère de la Justice du Québec (MJQ): Training in clear legal communication

Éducaloi offered **4 trainings** in clear legal communication (CLC) to **legal professionals and MJQ staff** in 2023-24:

- The legal world 101
- The legal world 102
- The 6 main principles of clear legal communication
- Writing clear emails for support staff

This is an important contribution since proper usage of CLC by legal professionals and a better understanding of the justice system by support staff

The Commission des services juridiques (CSJ): Providing information for a direct impact on the Quebec population

Éducaloi supported the CSJ's legal professionals in providing services to people entitled to legal aid by equipping them with simple information tools. The mandate sought two objectives:

- Inform those receiving **legal aid** on relevant subjects
- Inform the general public of the **services offered** by the CSJ

To achieve this, Éducaloi created:

- 1 "Legal aid" Web file consulted over 4,500 times and 6 articles that were clicked on 11,500 times
- **1 tool (checklist)** on housing for lawyers with *Rebâtir*
- 2 plain-language legal texts for SOS violence conjugale
- **3 Facebook Live**: Autorité parentale, Parental authority and Alcool au volant






