# I. Free Legal Information Clinics - phone and walk-in

Some legal information clinics may also offer legal advice. You can ask the clinic about this when you contact them.

# II. Free and Low-cost Legal Advice and Representation

## Quebec Bar Association's low-cost consultation with a lawyer

- Cost of a consultation with a lawyer varies between \$50 and \$60 depending on your region

- This cost is only for an initial consultation. If you ask the lawyer for further services
  (for example, further consultations or for representation) you must reach an
  agreement regarding fees.

# **Quebec Legal Aid**

- Provides free (or in some cases low-cost) legal representation for low-income people in all regions of Quebec

- Any lawyer in private practice can also accept legal aid work

#### Juripop

- Provides legal consultation and representation in most areas of law at \$60 per hour for people who slightly exceed the financial cut-offs for Quebec Legal Aid
- · The request must be made online, with proof of income

#### Rebâtir

- Provides four hours of legal consultation and advice for victims of sexual abuse and domestic violence
- Service is free of charge regardless of your income
- Consultation is with lawyers specialized in different fields, including family law, immigration, youth protection and criminal law

#### **Justice Pro Bono**

- Provides free legal representation in some areas of law to people who do not qualify for legal aid
